INTERNSHIP APPLICATION

Internship is the introduction to professional learning that provides a student the opportunity to integrate theoretical and practical knowledge with "hands on" experience in the "professional world." The internship should be the final activity in the course of study and is generally taken during the senior year. Students may register for a minimum of 6 to 12 academic credit hours to meet course requirements.

STUDENTS REQUIRING GORDON RULE COURSES WILL NOT BE PERMITTED TO REGISTER FOR INTERNSHIP.

To initiate the process for internship one must prepare/submit the following documents:

- 2. One copy of resume' (proofread/approved by FAMU Career Center)
- 3. One photo for file (you may provide a copy of your driver's license or student ID)

4. A Sociology/Criminal Justice unofficial transcript, degree audit evaluation form, which must be signed by your Academic Advisor with a recommendation for internship.
